- Updated CV that includes the following:
 - SA Citizenship
 - Race and gender **for employment equity reporting purposes to the Department of Employment and Labour (DEL)**
 - ID Number
 - Cellphone number and email address
- Latest statement of results
- A formal letter from the institution that states that the internship is a requirement in order to complete the qualification and that also advises the duration of the internship
- Correspondence and details of a contact name (Administrator) at the institution where the candidate is currently studying
- A clear copy of ID document
